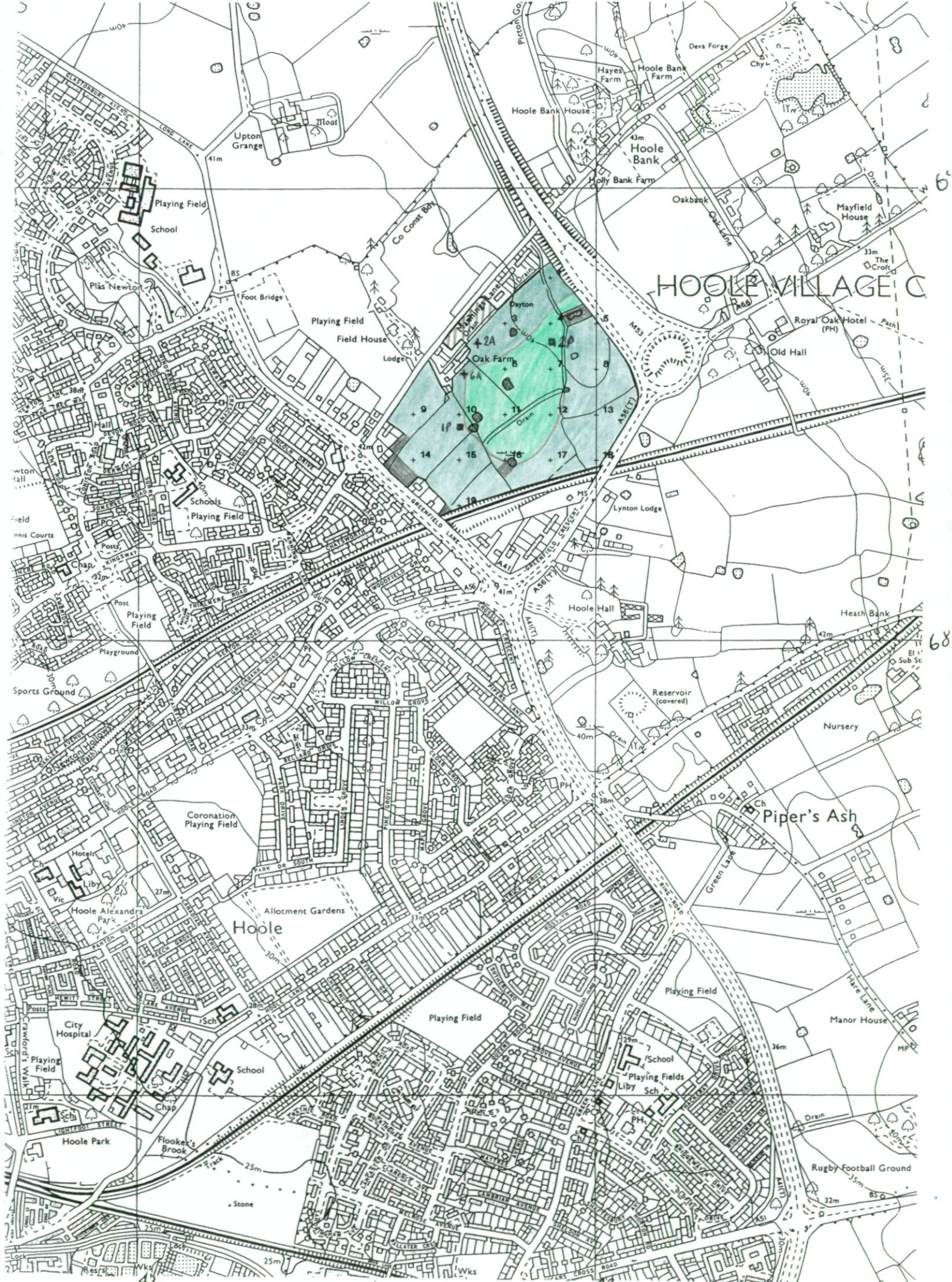

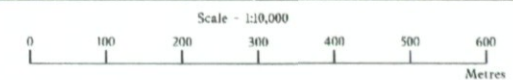
### Sample Point Map

- 1 Location of auger sample point

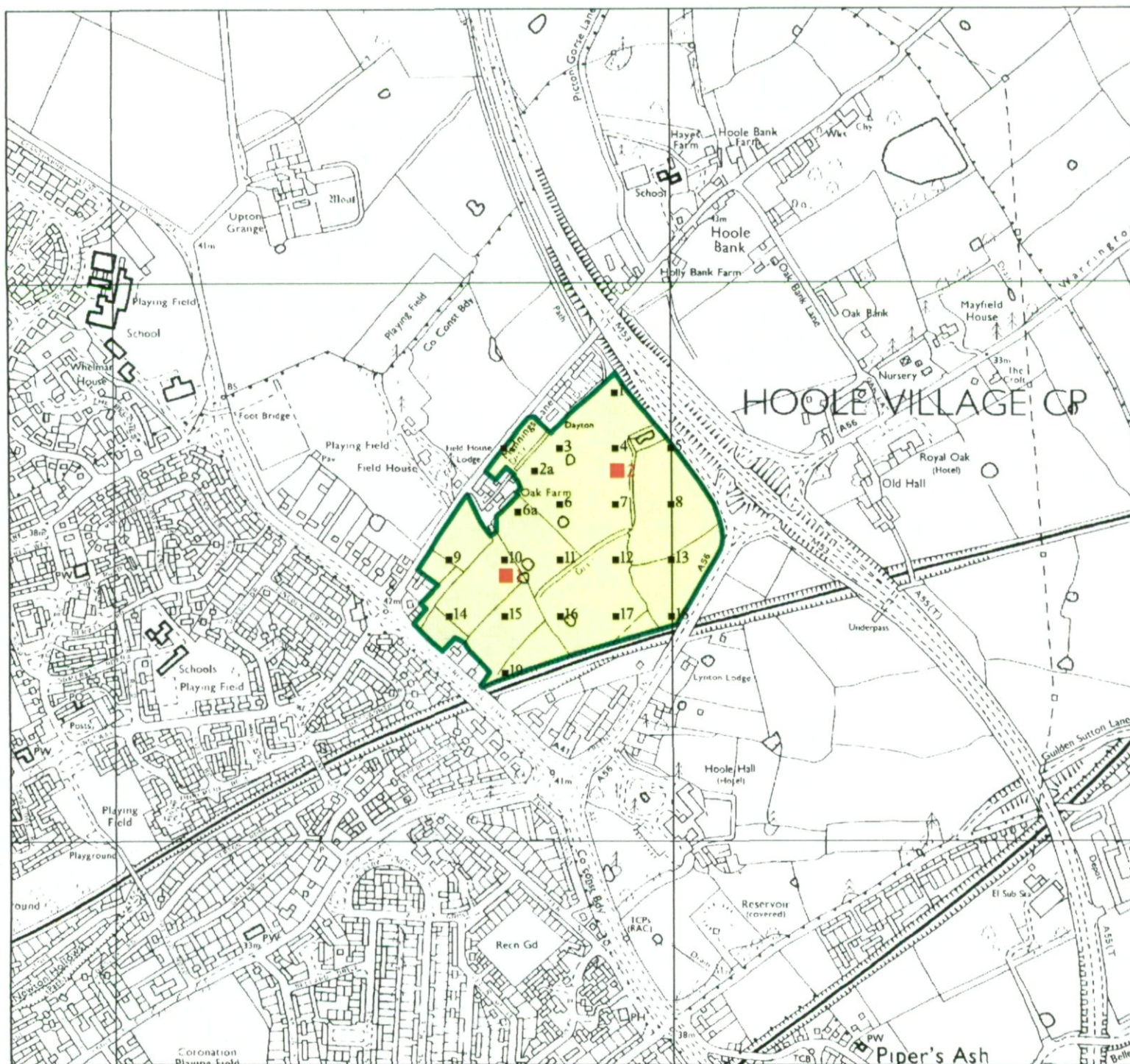


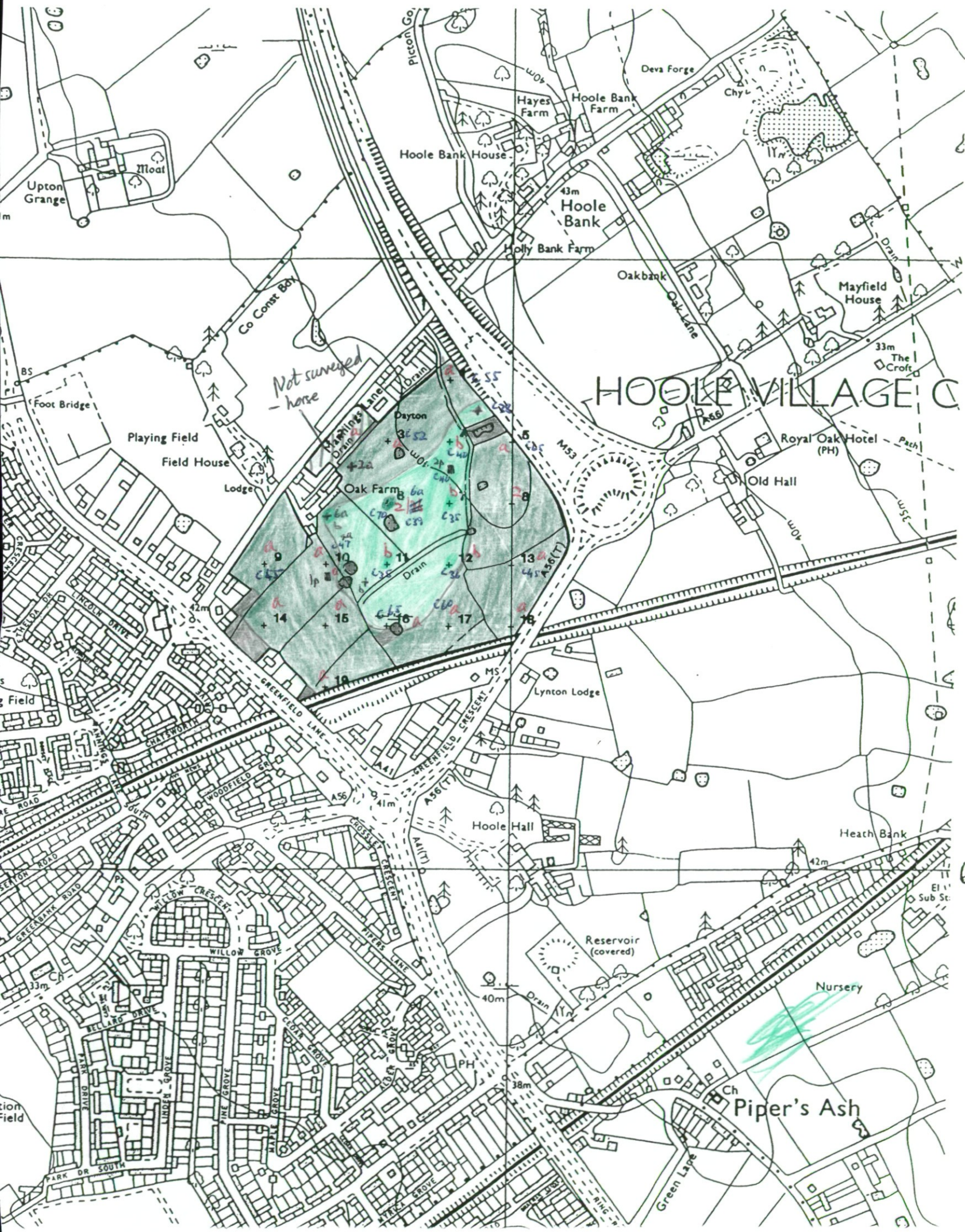
Boundary of

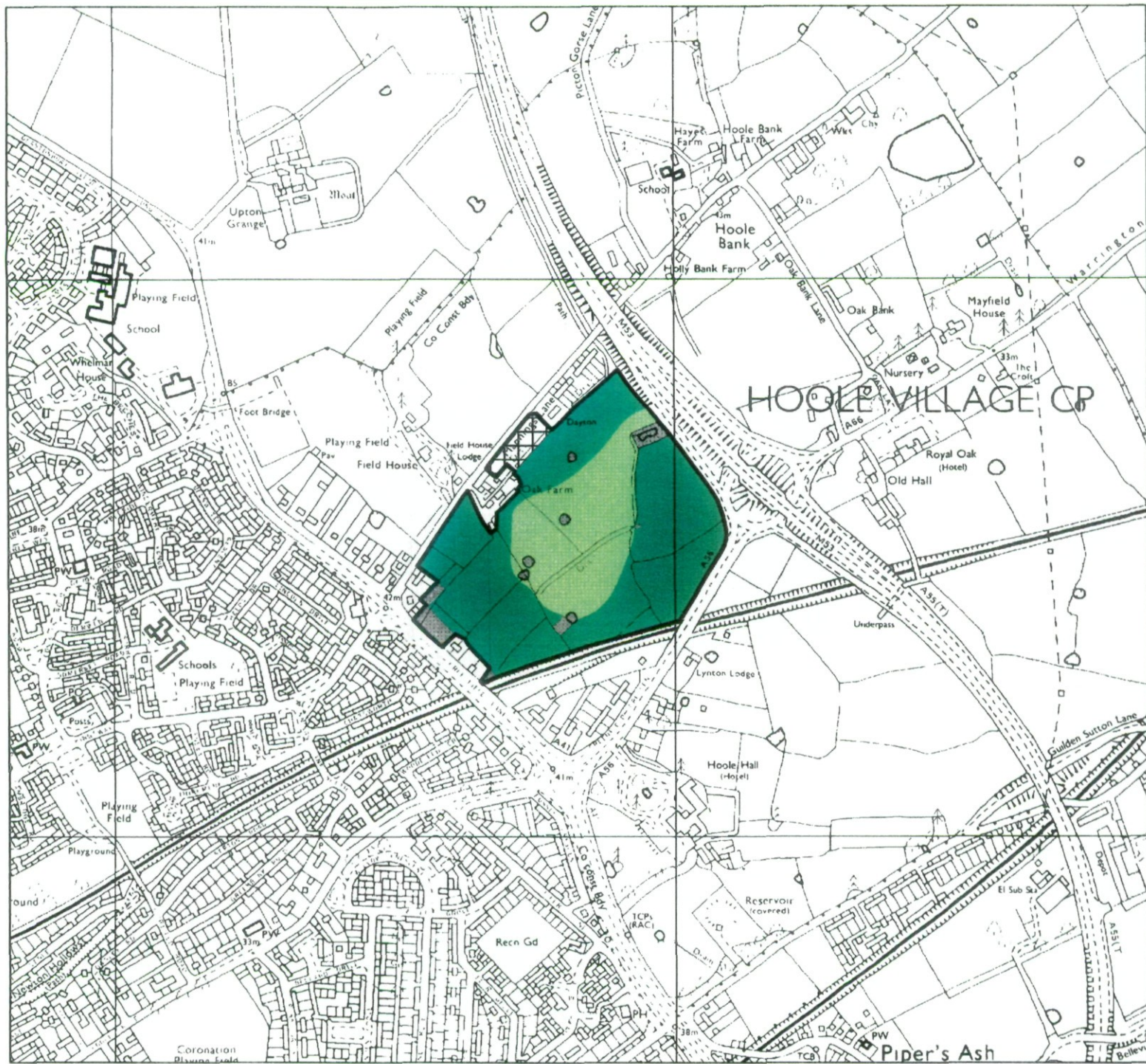

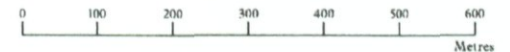
