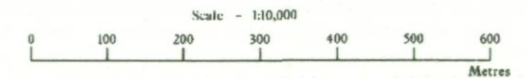







SAMPLE POINT MAP

-  LOCATION OF AUGER SAMPLE POINT

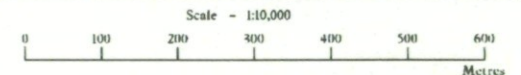
