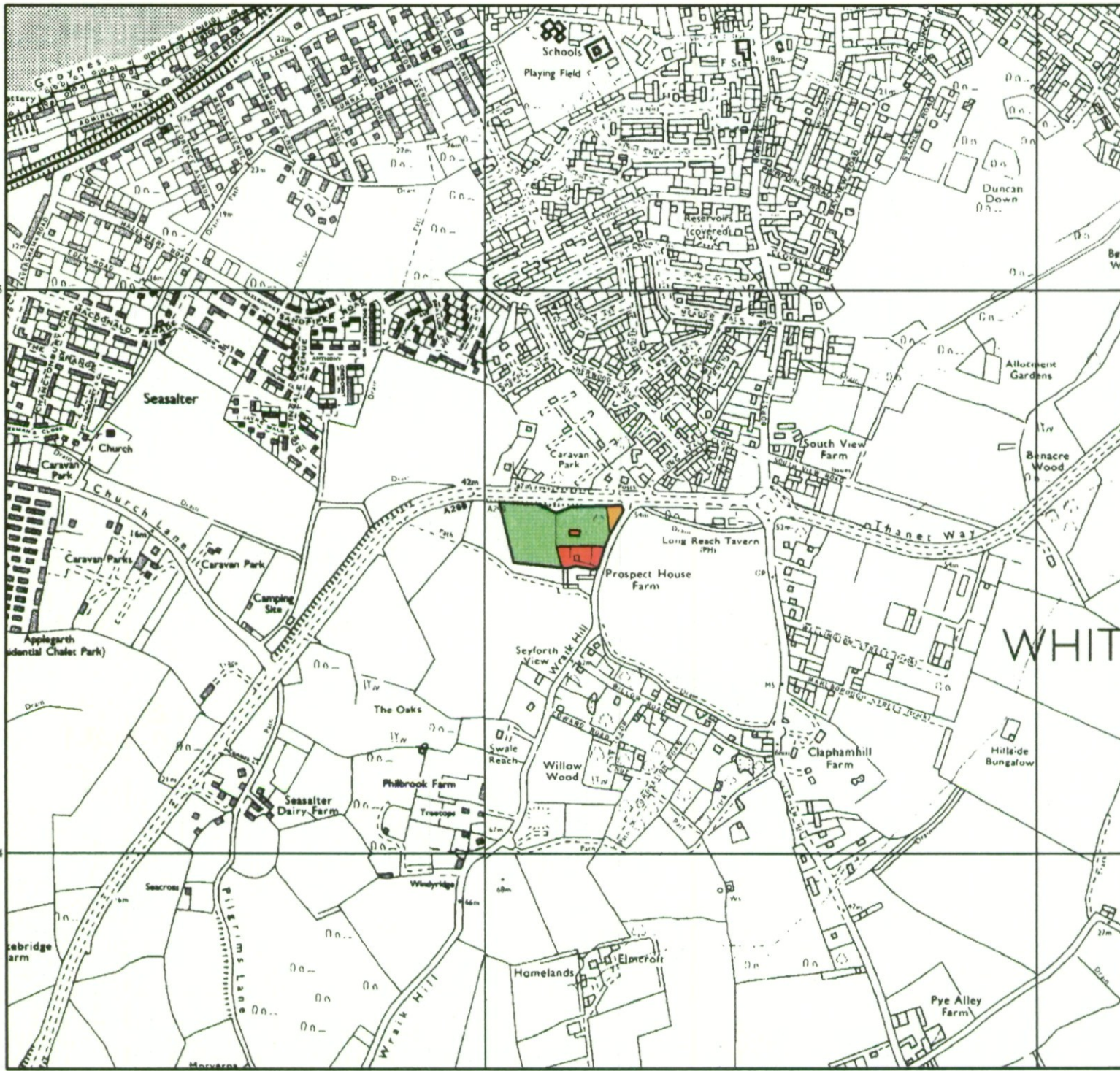






WHT16: Land near Prospect House Farm

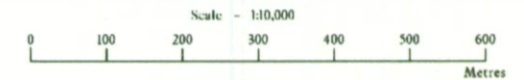

- ¹ LOCATION OF AUGER SAMPLE POINT

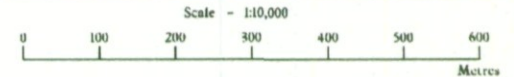
