




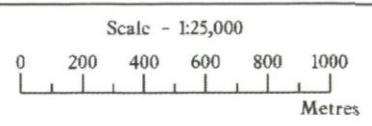

-  Other land

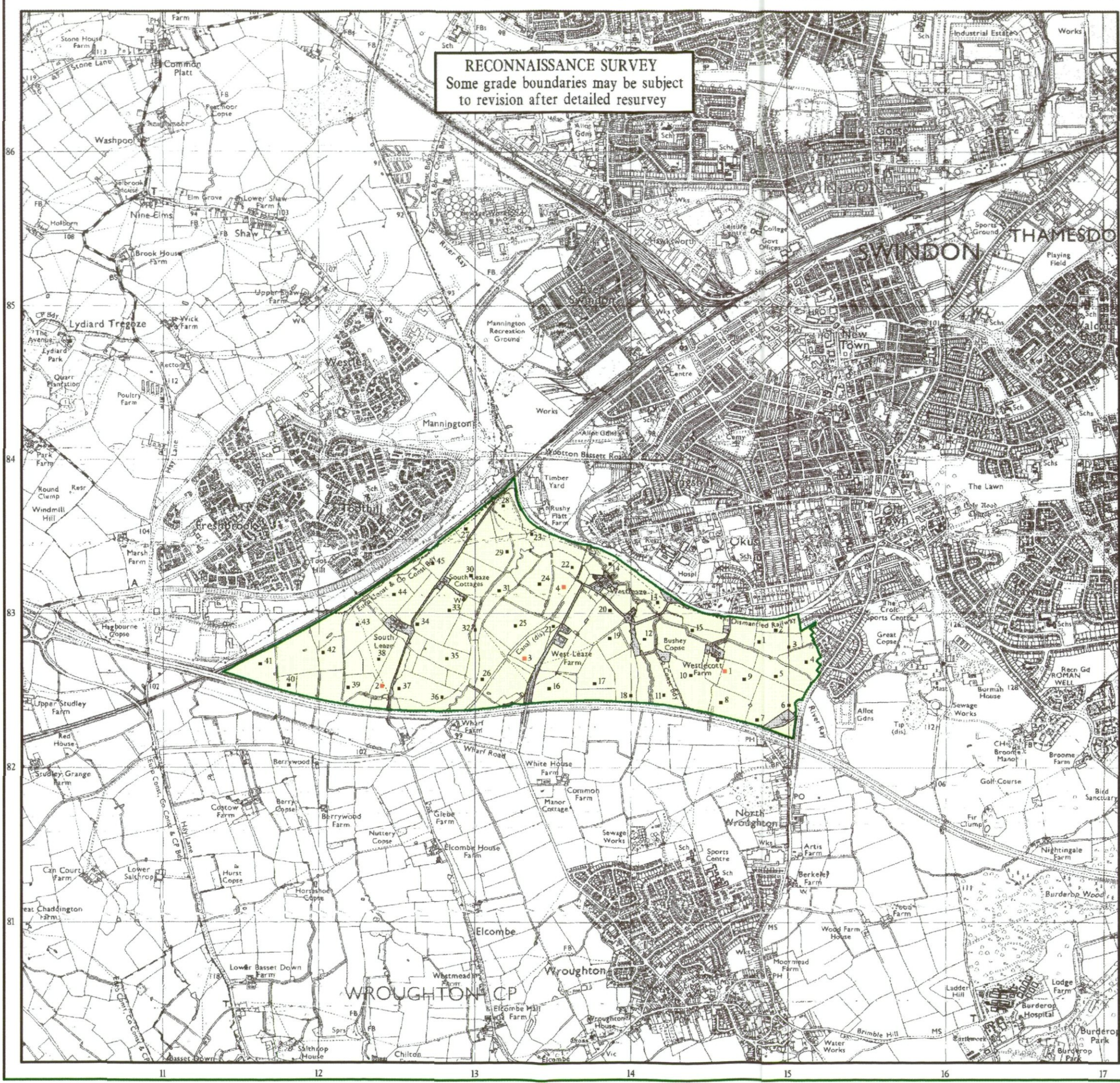

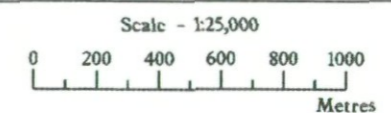
