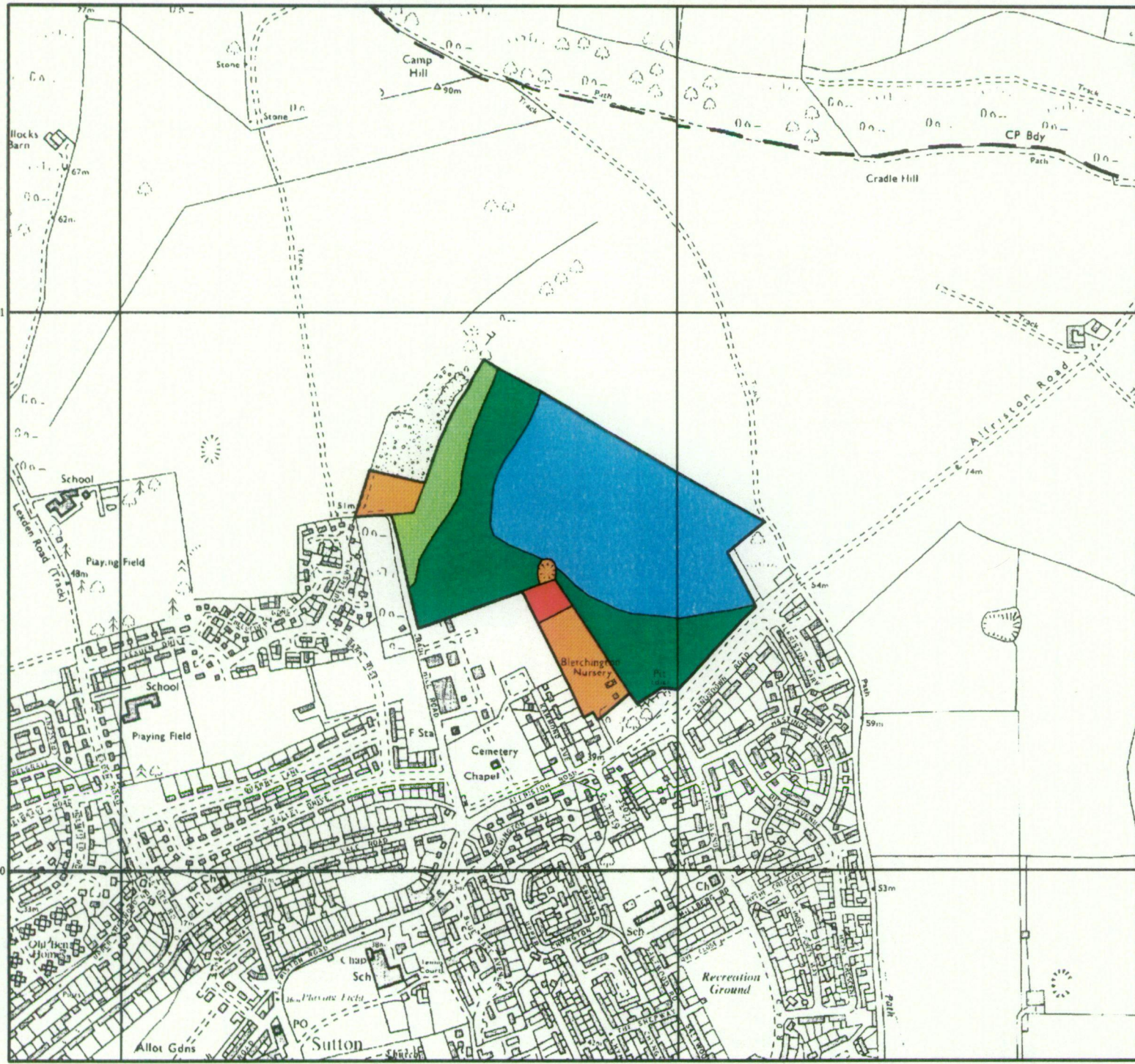

## Lewes District Local Plan Sites 1 & 2: Seaford



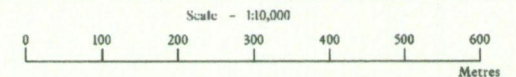

- LOCATION OF AUGER SAMPLE POINT

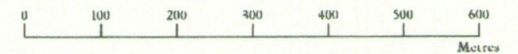
