INTRODUCTION

The Foreword and General Introduction to the Ancient Woodland Inventory county reports (1985-92) explain that the inventory is provisional and may be subject to revision as additional information is brought to the attention of English Nature. In addition woods change as a result of forestry practices or other developments.

This report provides details of those amendments which have been made to the provisional ancient woodland inventory for England since 1991. Sources of information have included recent English Nature, local authority and wildlife trust surveys along with comments on particular sites from the Forestry Commission and woodland owners or their agents. It incorporates amendments notified to the Woodland Section since c1985, when the first provisional inventory reports were produced. Further amendment reports will be produced in the future. For those woods listed, the information revises the details supplied in the provisional inventory reports (1985-1992) and accompanying printouts. No changes have been made to those woods not listed.

It is not possible, at this stage, to differentiate changes to a wood since c 1985 from amendments made as a result of new information being brought to our attention. This is, however, a long term objective for the inventory project.

The inventories for the counties of Cumbria, Hampshire, Kent, Lancashire, North Yorkshire and West Yorkshire are being re-issued during 1994. Reference should be made to these updated, but still provision, documents. Holders of other county inventories are invited to amend their own copies in accordance with the details given in Table 1. Clarification of the amended boundaries of individual sites can be obtained from this office if necessary. The five columns of figures are as described in the introduction of the ancient woodland inventory reports and printouts.

Table 2 shows the area of ancient woodland in England, by county, revising those figures published in Spencer and Kirby (1992) and given in the individual county reports.

Types of amendment

There are three main types of amendment included in this report (Table 3). A small number of sites have been removed from the inventory as they are no longer considered ancient woods. These are indicated in Table 1 as recent, or partly recent, woods. In addition a number of woods have been added to the inventory because field and other surveys suggest that they are ancient. However, the major category of revision relates to woods marked as ancient semi-natural in the provisional reports but which are now believed to be replanted. The majority of these are woods for which there was poor aerial photographic cover available to us when the inventory was drawn up initially. This was particularly a problem in north-east England and subsequent field surveys by English Nature and others have led to the changes seen in, for example, Durham and Northumberland. In only a few sites is the change the other way round. Thus, as would be expected from the method adopted in the inventory, the area of ancient semi-natural woods is over rather than under estimated. Other changes include changes in ownership, often the result of Forestry Commission disposals, and changes in conservation status as new SSSIs are notified or woods acquired by voluntary conservation bodies.

Future revisions

Despite these changes the inventories remain provisional. Further studies need to be carried out to progressively refine our knowledge of the extent and distribution of ancient woodland in England. Further changes may still be needed to some of those sites included in this report.

Comments on individual sites providing the information suggested in Appendix 1 are welcomed and should be sent to Woodland Section, English Nature, at the address below. For large data sets a different approach may be needed to incorporate any changes and I would be pleased to discuss this as necessary.

Acknowledgements

The changes detailed here could not have been incorporated without the help of a large number of people from conservation and forestry organisations, woodland owners and local government. I should like to express my thanks for the assistance received.
